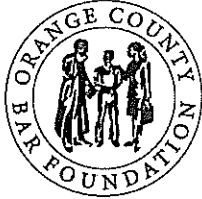

ENROLLMENT IN SHORTSTOP OR SSOA

- Enroll in the **ENGLISH** class by calling the SHORTSTOP office at **714.480.1925, ext. 112,114,119** for a series of two sessions. Session dates cannot be rescheduled.
- Enroll in **Stop Short of Addiction** by calling ext. **112,114,119** for a series of three session dates. Session dates cannot be rescheduled.

CLASS FEES:

- Please call the Shortstop or Stop Short of Addiction office for fees. Once you have called to enroll, mail check or money order with the name of your child and the dates that he/she has been registered for to: **P.O. Box 986 Santa Ana, CA 92701-0986**

AT THE CLASSES

- Dress **appropriately** for a courtroom setting. No hats, shorts, t-shirts, jeans, baggy pants, or gang attire.
- **No weapons allowed;** this includes knives. You may be subject to a metal detector search. If a weapon is found, a Court Marshal could arrest you.
